### **STRONG GROCERY ANCHOR**

Old Courthouse Square is anchored by a 39,177 SF Martin's, which celebrated their opening in April of 2019. Prior to it's opening, this location operated under the SHOP 'n SAVE banner since 2016 when SUPERVALU, the parent company of SHOP 'n SAVE, acquired 22 Food Lion locations in connection with the merger of Koninklijke Ahold N.V. and Delhaize Group NV/ SA. In November 2018, Giant Food Stores (Martin's parent company), acquired five SHOP 'n SAVE stores in West Virginia, Maryland, and Pennsylvania, converting to the Martin's banner. The store now features an expanded farm fresh produce department with more than 300 items. In addition, the store also features Martin's signature fresh departments including a full-service deli, a meat and seafood department, a full-service bakery and a floral department.

# New 10-year extension 4 additional five-year options \$14.6MM grocer (\$373 PSF)

In August 2021, the grocer executed a brand new 10-year lease extension through 2033, demonstrating its long term commitment to the property. The lease features four (4) additional five-year renewal options with \$.50 PSF increases at the exercise of each.

Co-anchoring the property is a 45,360 SF United States Postal Service, which has been at the property since 1995. This is a full service facility including passport appointments, money orders, P.O. Boxes, and extended lobby hours. This location serves an extensive trade area with the next closest location with passport services located in Williamsport, Maryland (13 miles northeast).

Old Courthouse Square is an established community center that has maintained a well-balanced mix of national, regional, convenience and necessity based tenants perfectly suited to serve the countless residential neighborhoods surrounding the property.

In addition to the USPS and Martin's, national/regional tenants include Family Dollar, AutoZone, Rent-A-Center, Super Shoes, Cricket Wireless, and One Main Financial. The property also features an extensive assortment of service based tenants such as Axiom Staffing Group, Med-Fast Pharmacy (d/b/a Moore's Pharmacy), and H&R Block, as well as a barber shop, dry cleaners, and a martial arts studio. Old Courthouse Square also benefits from the valuable traffic generated by multiple eateries including Sophia's, Subway, Pizza Hut, China King, Sumo Japanese, as well as two additional shadow pad users, Taco Bell and McDonald's which were recently built. The newest tenant to join the property is Maaco, which will occupy a 12,829 SF suite next to USPS. The 15-year lease commences in January 2022 and features 10% rental escalations every five years, with two (2) additional five year options, and a 15% rent escalation at the exercise of each.

### **EXCELLENT VISIBILITY AND REGIONAL LOCATION**

The property is located just one and one-half miles from I-81 (50,500 AADT) and offers outstanding site visibility from its location at the intersection of Edwin Miller Boulevard (Route 9) and N. Raleigh Street/Williamsport Pike (U.S. Route 11) where a combined 24,300 vehicles pass the property each day. Route 9 serves as a busy commercial corridor home to significant employment centers including the U.S. Social Security Administration, U.S. Internal Revenue Service, U.S. Agricultural Department and a Veteran's Affairs office.

### **STRONG AND GROWING DEMOGRAPHICS**

The center is advantageously positioned in Martinsburg, Berkeley County, West Virginia, one of the fastest growing bedroom communities of the Washington D.C. PSMA. Of West Virginia's largest counties, Berkeley saw the most growth in the entire state with a 67% population growth since 2000. An additional 11.0% is expected in the next five years as residents continue to flood into the state seeking the beauty of West Virginia at a less expensive and better quality of life than what other Washington D.C. Metropolitan areas can offer. This trend is expected to continue as businesses are also attracted to the county through its convenient location, business incentives, and low utility and real estate costs.

In the seven-mile radius surrounding the property there are 81,233 people earning an average household income of \$75,817. This trade area has also seen an explosive population growth over the last decade, with a projected growth of 11% through 2026. This tremendous growth coupled with its strong marketability advantageously positions Old Courthouse Square to serve a rapidly growing, underserved market area well into the foreseeable future.



Old Courthouse Square provides the successful purchaser significant upside with the immediate opportunity to increase cash flow and add value by leasing the currently available 22,973 SF of inline space in five suites, ranging from 3,253 SF to 5,800 SF, as well as an ATM location (40 SF).




